Expectations and rules for athlete and parent members of Star City Cheer

- Disrespectful behaviour including abusive behaviour, lying, and any other behaviour deemed inappropriate is grounds for dismissal. Please remember that disrespectful comments about Star City Cheer via any avenue, including social media, may result in dismissal from the program.
- Membership to Star City Cheer is a privilege and athletes and parents should be aware of the responsibilities and commitment they are making when they accept a place on Star City Cheer Team.
- Your behaviour as a member (athlete or associated adult) is a direct reflection of the Star City Cheer as a program as well as a direct reflection of your coaches. Please conduct yourselves with integrity and pride in the program we are building together.

Refund Policy

There are no refunds on any paid fees due throughout the year except for exceptional circumstances such as relocation or serious injury. The costs do not change based on the number/duration of practices in a given month. If an athlete is dismissed before the session's end for any reason, any and all their funds are used to keep coaches working and our gym rentals paid. There are no refunds on uniform or merchandise once ordered.

Practice Attire

Cheerleaders must wear appropriate clothing (t-shirt and shorts/leggings) and hair tied back and away from the eyes. A t-shirt or tank top is required to wear over a sports bra at every practice. All athletes will be required to wear indoor/cheer shoes.

Athletes should wear fitted clothing, with no sharp objects such as zippers or buttons. Fitted clothing decreases the chance of injury and allows coaches to better identify required corrections.

Medical Release

Liability Statement

Cheerleading is vigorous activity that includes tossing, falling, running, jumping, stunting, tumbling, pyramids and dancing. Due to the nature of this type of activity, the possibly of injury and death could occur. By signing this agreement, you agree that your child is physically active and fit to participate in this activity and has no known medical conditions that may compromise the safety of your child, other athletes or coaches

As parents/guardians of the above-mentioned athlete, a minor, I hereby grant the permission necessary to allow my child to participate in all events conducted by or attended by Star City Cheer including but not limited to: cheer practice, classes, competitions, and community events. I understand that accidents can be a result of the nature of the activity and can occur with or without any fault on either the part of the athlete, Star City Cheer, the coaches, the volunteers or facility where the activity/event is taking place. By allowing my child to participate, I am accepting the risk of an accident occurring or transmission of illness or disease (including but not limited to Influenza, colds, COVID-19, and COVID-19 related illnesses) and agree that the activities carried out in the course of participating in cheerleading are suitable for my child. I assume full responsibility for my child's participation. Thought participation, I am admitting awareness of the usual risks and danger inherent in participating in all of the activities offered by Star City Cheer and the possibility of injury both minor and serious, illness, property damage or loss of life resulting from the activities. I waive any and all claims that I may have against, and release all liability and agree not to sue, Star City Cheer, its arches or volunteers for any personal injury, property damage or loss sustained as a result of my child's participation in the programs, arising out of any cause whatsoever.
